ACKNOWLEDGEMENT OF RISK, RELEASE & INDEMNITY AGREEMENT

("AGREEMENT")

I, _____, hereby acknowledge that I have applied to enter on to and to engage in or to observe shooting and other activities at the Crazy Gun Dealer Range (the "RANGE".) I further acknowledge and understand that "shooting and other activities" includes any and all activities of any kind whatsoever in which I engage or observe while at the RANGE, whether sponsored by the Crazy Gun Dealer or not.

I ACKNOWLEDGE AND UNDERSTAND THAT SHOOTING ACTIVITIES ARE INHERENTLY HAZARDOUS

and involve **known, unknown and unanticipated risks** which could result in damage or destruction of property and physical or emotional injury, including paralysis or death, of myself or of other persons. The risks include, but **are not limited to**: being shot by or shooting myself or others (Gunshot wounds); Death; Permanent Disability; Head trauma and facial injuries ; Fractures, dislocations, sprains, strains and other soft tissue injuries; Contusions, lacerations, abrasions, and various forms of blunt force trauma; Impacts with other individuals or participants and/or their equipment; Perils and hazards arising from other guests; partial or total loss of eyesight or hearing; inhalation or other harmful contact with lead or other contaminants; and being struck by flying or falling objects; Bullet ricochets and/or "splash backs", Splash backs are bullets that hit steel or other hard surfaces and fragment, The fragments fly back toward the firing line and may cause bodily harm if it strikes a shooter or observer; A defective bullet or firearm may blow up in a shooter's face or hand, causing injury.

I understand that such risks cannot be eliminated without compromising the essential qualities of shooting activities.

I FURTHER ACKNOWLEDGE AND UNDERSTAND THAT the nature and condition of the RANGE facilities, Premises and environment is such that **known, unknown and unanticipated hazards** exist which create or contribute to **known, unknown and unanticipated risks** inherent in entering on to the RANGE, in using RANGE facilities and in engaging in or observing any activities of any kind whatsoever while at the RANGE. The hazards include, but are not limited to: slippery, loose or falling soil and rocks; unimproved, unmaintained, or uneven terrain, walkways, steps and roads; poisonous or dangerous plants, reptiles, insects and other animals; and falling trees and tree branches; Perils and hazards arising from natural features, plants, animals, insects, wet surfaces, tripping hazards and other types of contact with man-made and natural features; Perils and hazards arising from equipment failure or malfunction and potential misjudgment by staff; Remote locations that can delay the delivery of emergency medical services.

I understand that such hazards and risks cannot be eliminated without compromising the essential qualities of the RANGE facilities, equipment, premises and environment.

I FURTHER ACKNOWLEDGE AND UNDERSTAND THAT the Crazy Gun Dealer has no duty to undertake first-aid or rescue operations or procedures in the event any such property damage or physical or emotional injury occurs, and that any such operations or procedures may result in compounded or increased damages or injuries.

I FURTHER ACKNOWLEDGE AND UNDERSTAND THAT the Crazy Gun Dealer makes no warranty as to the design, manufacture, maintenance, condition or fitness for any particular purpose of any RANGE facilities or equipment, including, but not limited to: firearms, ammunition, eye/hearing protection, and first-aid supplies.

I FURTHER ACKNOWLEDGE AND UNDERSTAND THAT the activities in which I (or my child) will engage at or near the Range involve inherent and other risks. Some of those risks are described herein, others are unknown or unanticipated and I acknowledge that the activities are strenuous and dangerous and require a certain degree of physical condition, ability, maturity, and skill, I acknowledge that I am solely responsible for determining my (or my child's) suitability to participate in the

activities. I have (or my child has) the requisite skills, qualifications, physical and mental ability, and training necessary to properly and safely participate in the activities.

I understand that these activities are extremely dangerous and possibly life threatening. I (or my child) share(s) responsibility for my (his/her) safety and will follow instructions, make reasonable decisions, and act responsibly. The shooting range cannot ensure my (or my child's) safety and cannot eliminate all of the risks of the activities because they are inherent of the activity. I choose to voluntarily participate (or allow my child to participate) and observe the activities despite all risks. I assume all inherent and other risks and accept responsibility for any property damage and loss, and for any personal injury, illness, disability, emotional distress, and death that I (or my child) may suffer, whether described above or not.

In consideration of the Range providing services and facilities and allowing me (or my child) to participate in or observe the activities, I agree to the following:

Waiver and Release: I, (and on behalf of my child) agree to forever release and discharge the Range from and agree not to sue for any and all liability or claims I (or my child) may have for any property damage and loss, personal injury, emotional distress, illness, disability, and death, related to my (or my child's) participation or observation in the activities or use of any equipment or facilities. This release is for any type of claim, including breach of contract, fraud, or any other type of suit and includes losses alleged to be caused by negligence of Range to the fullest extent permitted by law.

Indemnity: I agree to defend, indemnify (meaning to pay or reimburse any amount required to be paid, including attorney fees) and hold the Range harmless from all claims, causes of action, liability, losses, or damages for any property damage, property loss or theft, personal injury, disability, death or other loss brought by or on behalf of me, my child, a family member, my estate, another participant or spectator, or any other person arising from or relating to my (or my child's) use of the property, facilities, and/or participation in the activities, including claims that the Range was negligent. **Being fully aware of all risks stated above** and As lawful consideration for being permitted by the Crazy Gun Dealer to enter on to the RANGE, to use RANGE facilities or equipment and to engage in or observe shooting and other activities at the RANGE, as either a Member or a Guest, I agree as follows:

I EXPRESSLY AGREE TO ACCEPT AND ASSUME ANY AND ALL RISKS KNOWN, UNKNOWN and UNANTICIPATED EXISTING ON THE RANGE AND IN ENTERING ON TO THE RANGE AND IN USING RANGE FACILITIES OR EQUIPMENT AND IN ENGAGING IN OR OBSERVING SHOOTING AND OTHER ACTIVITIES AT THE RANGE.

I **AGREE** to assume all responsibility and liability for any act or acts, even any negligent, reckless or criminal act or omission to act, of my Guests at the RANGE (I understand that "my Guests" includes any and all persons who are not a Member of the Crazy Gun Dealer Range who enter on to the RANGE, use the RANGE facilities or engage in or observe shooting and other activities at the RANGE as a result of my express invitation, permission or consent). I agree that I will ensure that each of my Guests read and sign an "Acknowledgement of Risk, Release & Indemnity Agreement."

I **AGREE** to abide by all Crazy Gun Dealer and RANGE Rules, and to ensure that my Guests do so as well. **It is my EXPRESS INTENT and I FULLY AGREE that I, my next of kin, heirs, guardians, representatives and assigns HEREBY RELEASE AND FOREVER DISCHARGE AND AGREE NOT TO SUE CRAZY GUN DEALER and It is my EXPRESS INTENT that this release SHALL FULLY BIND my next of kin, spouse, heirs, guardians, representatives and assigns whether I am alive or dead to FOREVER DISCHARGE AND AGREE NOT TO SUE CRAZY GUN DEALER** (I understand that Crazy Gun Dealer includes any and all officers, directors, attorneys, agents, employees, contractors, volunteers, guests, landlords, property owners, tenants and affiliated individuals or organizations of the Crazy Gun Dealer.) from and against any and all claims, demands, damages, expenses, causes of action, attachments of property, or liability of any kind whatsoever, that I, my next of kin, heirs, guardians,

representatives or assigns may have for property damage, personal injury or death resulting from me or my Guests entering on to the RANGE, using RANGE facilities or equipment, or engaging in or observing shooting and other activities at the RANGE, even if such claims, demands, damages, expenses, causes of action, attachments of property, or liability result partially or wholly from any act or acts, even any negligent act or omission to act, including negligent or omitted first-aid or rescue operations or procedures, by the Crazy Gun Dealer.

I AGREE that I, my next of kin, heirs, guardians, representatives and assigns HEREBY AGREE TO INDEMNIFY AND HOLD HARMLESS the Crazy Gun Dealer from and against any and all claims, demands, damages, expenses, causes of action, attachments of property, or liability of any kind whatsoever, including reasonable attorneys' fees and costs, that I, my next of kin, heirs, guardians, representatives or assigns, my Guests, or anyone else, may have for property damage, personal injury or death, whether suffered by me, by my Guests, or by anyone else, resulting from me or my Guests entering on to the RANGE, using RANGE facilities or equipment, or engaging in or observing shooting and other activities at the RANGE, even if such claims, demands, damages, expenses, causes of action, attachments of property, or liability result partially or wholly from any act or acts, even any negligent act or omission to act, including negligent or omitted first-aid or rescue operations or procedures, by the Crazy Gun Dealer.

I AGREE and FULLY BIND that I, my next of kin, heirs, guardians, representatives and assigns HEREBY AGREE TO BE FULLY LIABLE to the Crazy Gun Dealer that if I, my guest or child, should use a firearm intentionally, accidentally, unknowingly or for any reason, to inflict body injury or death to myself or others at the Range, **that my estate, next of kin, heirs, guardians, representatives and assigns shall be financially responsible to the Crazy Gun Dealer for all actual and perceived costs and losses due to my actions plus treble damages of all those costs.**

I ACKNOWLEDGE AND AGREE that this Agreement shall be interpreted and enforced under the laws of the State of Texas, and that the venue for any action or proceeding shall be the State of Texas, without regard for the conflict of law rules of the State of Texas.

I FURTHER ACKNOWLEDGE AND AGREE that this Agreement is intended to be as broad and inclusive as permitted by law, and that if any provision or portion is held to be invalid, void or otherwise unenforceable, I agree and intend that the remaining provisions or portion shall continue and remain in full legal force and effect.

I FURTHER ACKNOWLEDGE AND AGREE that it is my understanding and intent that this Agreement, and any signed written amendments or modifications to it, shall remain in full force and effect from the date of execution and ever after and shall be applicable to each and every occasion that I or my Guests enter on to the RANGE, use RANGE facilities or equipment or engage in or observe shooting and other activities at the RANGE.

I have carefully read this "Acknowledgement of Risk, Release & Indemnity Agreement" and fully know its contents, I acknowledge that no other inducement, assurance or guarantee has been made to me in consideration of my signing this Agreement, **which I sign voluntarily and of my own free will.** I further acknowledge and agree that this Agreement may be amended or modified only by a writing signed by me and by an authorized agent of the Crazy Gun Dealer.

I UNDERSTAND THAT BY MY SIGNATURE I AM GIVING UP SUBSTANTIAL RIGHTS, THAT I AM AGREEING NOT TO SUE CRAZY GUN DEALER AND RELEASING AND HOLDING HARMLESS CRAZY GUN DEALER OF ALL LIABILITY.

In signing this release, I acknowledge and represent that:

A. I have read the foregoing release, understand it, and sign it voluntarily as my own free act and deed;

B. No oral representation, statements or inducements, apart from the foregoing written agreement, have been made;

C. I am at least eighteen (18) years of age and fully competent; or I am under the supervision of a fully competent adult;

Crazy Gun Dealer Range – Cease Fire Bell System

ANY time you here bells the range is COLD!!!!

BELL SYSTEM AND RANGE OPERATION

THIS RANGE OPERATES ON A CEASE FIRE SCHEDULE. THE ENTIRE RANGE FOLLOWS THE SAME SCHEDULE. EVERY 20 MINUTES STARTING AT THE TOP OF THE HOUR WE HAVE A MANDATORY 5 MINUTE CEASE FIRE. THE CEASE FIRES TAKE PLACE FROM :0-:05, AND :20-25, AND :40-45. THAT IS EVERY 20 MINUTES STARTING AT THE TOP OF THE HOUR. 3 TIMES PER HOUR EVERYONE STOPS SHOOTING FOR 5 FULL MINUTES. YOU GET 5 MINUTES BREAK, 15 TO SHOOT, 5 TO BREAK, 15 TO SHOOT, OVER AND OVER ALL DAY. THE 5 MINUTE CEASE FIRE IS EVERYONE'S TIME TO GO DOWN RANGE SAFELY AND SET UP, OBSERVE, OR PULL THEIR TARGETS. THIS IS HOW THE ENTIRE RANGE WORKS AND IT IS CRITICAL THAT YOU UNDERSTAND THIS SYSTEM. THERE IS A BELL THAT RINGS DURING THE ENTIRE CEASE FIRE SO ANY TIME YOU HEAR THE BELL RINGING YOU KNOW THAT IT IS NOT SHOOTING TIME. ANY TIME YOU HEAR THE BELL RINGING YOU SHOULD UNLOAD YOUR GUNS AND PUT THEM DOWN IMMEDIATELY. **DO NOT TOUCH YOUR GUNS FOR THE ENTIRE 5 MINUTES AND THEN ONLY AFTER THE RSO GIVES THE COMMAND!!!** MAKE SURE THAT EVERYONE WITH YOU AND EVERYONE AROUND YOU KNOWS WHEN THERE IS A CEASE FIRE TAKING PLACE. IT IS YOUR SAFETY ON THE LINE. THERE IS NO MAGICAL SAFETY SYSTEM HERE OTHER

THAN YOUR OWN BRAIN. **A FEW KEY POINTS**

***JUST BECAUSE THE BELL STARTS RINGING DOES NOT AUTOMATICALLY MEAN ITS SAFE TO WALK DOWN RANGE**

SOME PEOPLE CANNOT HEAR THE BELL RINGING FOR WHATEVER REASON AND DO NOT STOP PROMPTLY —**YOU**

MUST WAIT UNTIL EVERYONE STOPS SHOOTING AND PUTS THEIR GUNS DOWN AND THE RSO CALLS THE FIRING

LINE SAFE BEFORE ANYONE MAY WALK DOWN RANGE

***JUST BECAUSE THE BELL STOPS RINGING DOES NOT AUTOMATICALLY MEAN ITS SAFE TO START SHOOTING**

SOME PEOPLE CANNOT GET THEIR TARGETS SET UP WITHIN THE 5 MINUTE TIME FRAME AND THEY MAY STILL BE DOWN RANGE AFTER THE BELL STOPS RINGING. SOME PEOPLE MAY JUST BE INCONSIDERATE AND DECIDE TO GO DOWN RANGE 4 MINUTES INTO THE CEASE FIRE AND WALK BACK AFTER THE BELL STOPS RINGING. REGARDLESS, **YOU MUST WAIT FOR ALL SHOOTERS TO MAKE IT BACK FROM DOWN RANGE AND ALL SHOOTERS TO CALL THE FIRING LINE HOT, BEFORE FIRING AGAIN.** WHETHER THEY ARE GENUINELY SLOW OR ARE INCONSIDERATE OF OTHERS, YOU MUST ALWAYS WAIT FOR EVERYONE **ON ALL RANGES** TO COME BACK FROM DOWN RANGE BEFORE SHOOTING. SHOOTING WHILE ANYONE ELSE IS DOWN RANGE IS AN IMMEDIATE INFRACTION AND MEMBERS LOSE THEIR MEMBERSHIP WITHOUT REFUND OR RECOURSE

*TAKE EXTRA CAUTION AND TIME WHEN THE BELL STOPS RINGING TO SCAN DOWN RANGE AND MAKE SURE THE ENTIRE RANGE IS CLEAR BEFORE SHOOTING AGAIN. MAKE SURE EVERYONE IN YOUR GROUP UNDERSTANDS THAT THEY ALWAYS NEED TO WAIT AND SCAN DOWN RANGE BEFORE SHOOTING. EVERY SINGLE TIME. **REMEMBER, ANYONE MAY CALL CEASE FIRE, BELLS OR NO BELLS, IF THEY SEE A SAFETY ISSUE AND IT IS YOUR RESPONSIBLTY TO DO SO! I**

RANGE & FIREARM SAFETY BASICS

THERE ARE 4 SAFETY BASICS THAT, AS LONG AS YOU FOLLOW THEM, YOU WILL NEVER HAVE ANY KIND OF SAFETY INCIDENT AT ANY GUN RANGE OR SHOOTING EVENT

1 - RANGE SAFETY – LOOK **BOTH WAYS**, LEFT AND RIGHT, DOWN RANGE BEFORE SHOOTING — **EVERY SINGLE TIME.** LIKE CROSSING THE STREET. IF YOU LOOK BOTH WAYS EVERY TIME YOU WILL NEVER, EVER, EVER GET HIT BY A CAR. SHOOTING ON A RANGE IS THE SAME. IF YOU LOOK BOTH WAYS EVERY TIME BEFORE SHOOTING, YOU WILL NEVER BE INVOLVED IN ANY KIND OF SAFETY INCIDENT THAT PUTS ANYONE IN DANGER OR DOES HARM TO ANYONE. IT IS VERY SIMPLE. LOOK BOTH WAYS EVERY TIME BEFORE SHOOTING TO MAKE SURE THE DOWN RANGE IS CLEAR OF OTHER SHOOTERS. YOU CAN THEN REST ASSURED THAT YOU ARE NOT GOING TO DO HARM TO ANYONE. ALWAYS LOOK BOTH WAYS BEFORE SHOOTING, EVERY SINGLE TIME.

2- FIREARM SAFETY — **KEEP ALL GUNS POINTED DOWN RANGE AT ALL TIMES!** IF CARRYING A GUN FROM A VEHICLE TO THE FIRING LINE THE BARREL SHOULD BE POINTED AT THE GROUND. AT NO TIME SHOULD THE BARREL OF YOUR GUN EVER POINT AT ANY OTHER PERSON, WHETHER YOUR GUN IS LOADED OR UNLOADED,

WHETHER ACCIDENT OR ON PURPOSE. YOU POINT IT STRAIGHT DOWN AT THE GROUND OR DOWN RANGE. THAT'S IT, NO POINTING IT LEFT, NO POINTING IT RIGHT. NO SIDEWAYS, NO DIAGONAL. IF ALL OF YOUR GUNS ARE LAID OUT THEY SHOULD ALL BE POINTED THE EXACT SAME DIRECTION, DOWNRANGE. LIKE HOW YOU SET THE TABLE — ALL YOUR SILVERWEAR POINTED STRAIGHT AHEAD. IF YOU POINT YOUR GUNS SIDEWAYS OR BACK TOWARDS YOU THEN YOU ARE ASKING FOR A DISASTER. POINT ALL GUNS STRAIGHT AHEAD DOWN RANGE AT ALL TIMES.

3- FIREARM SAFETY - KEEP ALL GUNS UNLOADED AT ALL TIMES UNTIL READY TO SHOOT! DO NOT LOAD THE GUN UNTIL THE MOMENT BEFORE SHOOTING. AFTER SHOOTING MAKE SURE THE GUN IS UNLOADED BEFORE SETTING IT BACK DOWN. NEVER LEAVE A LOADED GUN LAYING AROUND WHERE YOU OR OTHERS CAN PICK IT UP LOADED. ALWAYS ASSUME EVERY SINGLE GUN YOU ENCOUNTER IS LOADED AND READY TO SHOOT AND UNSAFE. THE ONLY WAY YOU KNOW A GUN IS SAFE TO HANDLE IS IF YOU CAN VISIBLY TELL IT IS INOPERABLE, UNLOADED, AND IF POSSIBLE WITH THE BREACH OPEN - BOLT OUT, SLIDE OPENED, MAGAZINE REMOVED. A LOADED GUN IS A DANGEROUS GUN AND IF YOU DON'T WANT YOUR GUNS TO BE DANGEROUS ALL THE TIME, YOU NEED TO KEEP THEM UNLOADED UNTIL READY TO SHOOT. KEEP ALL GUNS UNLOADED UNTIL THE MOMENT BEFORE SHOOTING.

4- FIREARM SAFETY — NEVER EVER TOUCH THE TRIGGER UNTIL YOU ARE READY TO SHOOT AT YOUR TARGET. YOU SHOULD NEVER PICK UP A GUN BY THE TRIGGER. YOU SHOULD NEVER TOUCH THE TRIGGER WHILE HANDLING A GUN. YOU SHOULD NEVER EVEN TOUCH THE TRIGGER UNTIL YOU HAVE YOUR TARGET IN YOUR SIGHTS AND YOU ARE COMFORTABLE WITH PULLING THE TRIGGER. IT IS COMPLETELY UNACCEPTABLE TO EVER TOUCH THE TRIGGER AT ANY OTHER TIME THAN WHEN YOU ARE PREPARED TO SHOOT THE GUN. NEVER EVER TOUCH THE TRIGGER UNTIL YOU ARE READY TO FIRE THE GUN.

IF YOU GET ANY OF THESE 4 PRINCIPLES WRONG IT COULD BE THE END OF YOUR LIFE OR SOMEONE AROUND YOU. THESE ARE NOT SUGGESTIONS! THESE ARE MANDATORY POLICIES! INITIAL _____

RE-CAP ON THE CEASE FIRE BELL SYSTEM

IT RINGS EVERY 20 MINUTES FOR 5 MINUTES STARTING AT THE TOP OF THE HOUR. THE BELL RINGS FOR THE FULL 5 MINUTES SO WHILE IT IS RINGING IT IS NOT SHOOTING TIME. DO NOT TOUCH YOUR GUNS WHILE THE BELL IS RINGING. **MAKE SURE EVERYONE HAS MADE IT BACK FROM DOWN RANGE AND ALL SHOOTERS HAVE MADE THE FIRING LINE HOT BEFORE SHOOTING AGAIN.**

RE-CAP ON RANGE SAFETY

- 1 ALWAYS SCAN DOWN RANGE BEFORE SHOOTING, EVERY SINGLE TIME.
- 2 KEEP ALL GUNS POINTED DOWN RANGE AT ALL TIMES.
- 3 KEEP ALL GUNS UNLOADED AT ALL TIMES OTHER THAN SHOOTING.
- 4 NEVER EVER TOUCH THE TRIGGER UNTIL YOU ARE READY TO FIRE THE GUN.

RANGE RULES AND REGULATIONS

RANGE AREA IS IMMEDIATELY INSIDE THE FIRST LOCKED GATE All federal, state,

and local firearm laws MUST be obeyed.

IN THE EVENT OF AN EMERGENCY: call a "Cease Fire", and call 911 IMMEDIATELY! There is a phone on premise marked 911. The address is 1702 West Lakeshore Dr Alvarado, TX 76009 And is Posted Around The Firing Area and Firing Line! If Possible have someone UNLOCK the gate before arrival of emergency services!

Safety will be the utmost thought at all times on the range and is every shooter's first and foremost responsibility! If there are any safety issues or other problems with any range area or facility, NOTIFY Crazy Gun Dealer IMMEDIATELY and Remember ANYONE may call a CEASE FIRE at ANYTIME!

ANYONE Entering Range Area MUST Have Signed Copies of Range Rules, Liability Waiver, and Bell System Rules ON FILE at the Crazy Gun Dealer STORE!!!! This INCLUDES YOUR GUESTS. NO One may enter as a MEMBER or YOUR GUEST who does not have signed copies of ALL these documents on file with the Crazy Gun Dealer. It is MEMBERS responsibility to plan ahead for their guest and complete and turn in all documents during business hours of the store not the range, before entering the Range Area. Entrance by ANYONE who has not Signed ALL listed documents and filed them with the Crazy Gun Dealer is UNAUTHORIZED , CRIMINALLY TRESPASSING and WILL BE PROSECUTED without exception!!!!!!!!!!!!!!!!!!!!

Range Hours and Days of Operation Will Vary. Range may be Closed or Unavailable at Times for Special Events or Classes. Range May Closed on Short Notice Due To Weather or Emergency. Check Range Website for Current Hours and Availability, BEFORE Coming

Pregnant women, or people subject to seizures, are not allowed on the range without their doctor's permission and your presence on the range area will be your implied assertion that you have that permission.

Crazy Gun Dealer Range is a family-oriented facility and we have the right to refuse service to anyone for ANY reason Regardless of Membership Payment and Without Refund for Fees Paid

YOU CERTIFY that you are familiar with your firearm(s), and that you are able to load, handle, fire, unload and make safe your firearm(s). If you are unsure about handling your firearm(s), you are required to be under DIRECT supervision of an experienced instructor or shooter, or attend a basic gun training class for your firearm(s) before enjoying our range.

Dangerous behavior is NOT TOLERATED: If Crazy Gun Dealer determines a person's behavior to be a danger or threat to others, they may, at his/her discretion, take the person's firearm(s), make them safe and temporarily confiscate them. They will then escort the person to the front gate of the range and at that time return the firearm(s) to the person. **This will constitute permanent loss of privileges at the range without refund or recourse.** The RSO may also contact the Johnson County Sheriffs Office to have a deputy come to the range and issue a criminal trespass warning to the person.

INITIAL _____

Crazy Gun Dealer Shooting Range is a "cold range". All guns are to be kept in a safe and empty condition until on the firing line.

Do NOT EVER leave a loaded firearm unattended

No alcoholic beverages, illegal drugs or medications that impair judgment, nor persons who have been consuming those items, will be allowed in the range area or premises. Persons smelling of alcohol on their breath or who appear impaired will be required to leave the facility IMMEDIATELY and RSO Decisions ARE FINAL!!!!

Shooter's glasses or tempered glasses (eye protection) is MANDATORY and must be worn at all times while inside the Range area by EVERYONE including shooters, spotters or spectators. Proper **Prescription Safety Glasses** are Acceptable.

Hearing protection is MANDATORY and must be worn at all times while inside range area by EVERYONE including shooters, spotters or spectators.

Children must be supervised at all times while inside the range area or on premises. Children under the age of 18 MUST be escorted by parent or legal guardian at ALL times in Range Area and AT FIRING LINE. A responsible adult must accompany persons under twenty-one (21) years of age. This adult shall act as a coach, and MUST remain with the minor(s) at all times while the minor(s) utilizes the range or is in the range area

No explosive ammunition will be allowed in the range area

All firearms must be clear, unloaded with the action open and UNTOUCHED while in the range area, except while actively firing. Concealed Carry Weapons that are loaded should **PLEASE** be locked in Your Car While In the Range Area for Safety. There will be plenty of LOADED Guns at the Firing Line

All firearms must be clear and bagged or in a container when **ENTERING** the **RANGE AREA** and **BEFORE LEAVING** the **FIRING LINE**.

No person will be allowed forward of the firing line **EXCEPT DURING CEASE FIRE**

Only persons who are actively shooting are allowed inside of the firing area. ONLY the active shooter and CERTIFIED instructors may be AT the firing line.

Only firearms in good working condition are allowed in the FIRING AREA. (user is held responsible) No more than two persons are permitted at each firing lane. Coaching may occur at the **PERMISSION** of range staff. All fired rounds must impact the **BULLET MOUND AREA ONLY**. YOU will be responsible for ANY that do not. There is NO excuse for a bullet to miss the Bullet Mound Area.

All firearms and ammunition are subject to inspection at **ANYTIME** by staff for cleanliness, workability and safety NO Rapid fire! Two-second rule is in effect (2 seconds between rounds)

All firearms must be **POINTED DOWN RANGE** in a safe manner **AT ALL TIMES**

NO tobacco use of **ANY KIND** (including e-cigarettes) or gum allowed on premises. Food and Drinks may **NOT** be consumed in the shooting area But **MUST** be **KEPT and CONSUMED in the DESIGNATED BREAK AREA** away from ALL shooting. LEAD is Toxic and can be transferred by contact even when eating and drinking. Wash Hands Thoroughly with Soap and Water and Consider Bringing or Purchasing Lead Wipes for Skin to wipe down upon completion of any shooting or ammo handling.

Use of black powder firearms is prohibited **WITHOUT SPECIAL PERMISSION**

Photo identification and Photo Member Card required for use of range facilities. **INITIAL** _____

EACH & EVERY person (members, family members, guests and visitors) entering the range and or firing area **MUST** have signed an "Acknowledgement Of Risk, Release & Indemnity Agreement" and a "Range Rules and Regulations Form" or **IMMEDIATELY EXIT THE PREMISES, as YOU ARE CRIMINALLY TRESPASSING**

Targets may be brought into the range ONLY if approved . Numerous targets are available for a reasonable price at Crazy Gun Dealer Pro Shop. Shoot at approved targets only. Shooting at rocks or any other inappropriate targets that cause ricochets or may start a fire is prohibited. Don't bring your junk or trash to the facility to shoot at! Approved Targets only! No glass, jugs, fruit, etc. Shooting any flammable or exploding material is prohibited; this includes Tannerite or any other similar binary compounds. Do not move targets from their locations. When a Range Officer is on duty, they are in direct charge of the range and all participants at all times. Shooters must obey his/ her directions and Failure to follow RSO instructions or cooperate with other shooters will not be tolerated.

The Range Officer will ban from the range any person handling a firearm in an unsafe or careless manner or who is uncooperative with the RSO or other shooters. The Range Officer may also void membership should such conduct warrant without refund or recourse.

FIRING LINE PROCEDURE:

Take position at the lane assigned to you. **DO NOT** change lanes. Only one loaded gun at a time. No other gun handling behind the firing line. Only one shooter and coach permitted per firing lane; only one un-cased firearm permitted at the firing lane at a time. Persons not shooting or coaching are not permitted at the firing line. Once in your firing lane, all firearms must be unloaded from the bag or case on the bench (not the floor) and pointed down range at all times. When shooting, only 1 firearm may be fired at a time per stall, no drawing from a holster Any firearm that is not currently being used must have the magazine out and the slide locked back. Only unloaded firearms should be laid down on the bench, and no loaded firearms should be handed to another person. Once you're done shooting, all firearms should be unloaded, placed back into your bag or case **on the bench while still being pointed down range.**

Firearms may not be exchanged with another lane while the firing line is hot, ONLY during a CEASE FIRE, (NOT WHILE PEOPLE DOWN RANGE!) and the gun must be unloaded, open and clear.

Shooters must load and unload their own firearms. If a mechanical malfunction occurs, DO NOT REMOVE JAMMED OR MALFUNCTIONING FIREARMS away from the firing line; **KEEP pointed Down Range SAFELY!!!!** If you can safely correct the issue while keeping the firearm pointed downrange, then do so **WHILE KEEPING THE FIREARM POINTED DOWNRANGE!**

Only line of sight firing is permitted. (NO drawing from the hip or holster.) Keep your finger off the trigger until on target.

When leaving the firing line temporarily, lay the firearm with the muzzle down range and the action open and the gun UNLOADED and CLEAR.

CEASE FIRING MEANS... STOP SHOOTING AND STEP BACK from lane.

ANYONE at ANYTIME may call a CEASE FIRE For SAFETY REASONS. If you see something or someone being unsafe, **immediately call "Cease Fire".**

CEASE FIRE: On this command, unload your firearm and lay it down with the magazine out and the action open. Then step behind the yellow line and wait for any instructions. Instructions from the Range Safety Officer or other staff members must be obeyed immediately and without question.

VANDALISM: Any person seen firing at lights, baffles, carriers or any other range property or equipment will have their membership suspended, and will be reported to the proper authorities for appropriate action. Firing at boxes, cups, or other objects is prohibited. Only targets authorized by CGD will be permitted. All shooters will be held accountable and will pay for any damage you cause including replacement and installation charges. **INITIAL_____**

PERMISSABLE FIREARMS:

MOST modern weapons within reason may be fired at the firing line. ALL shotguns MUST be fired at the skeet lanes including self defense shotguns. **ALL SHOTGUNS MUST Shoot STEEL SHOT ONLY.** PISTOL GRIP Shotguns must have CGD Permission to shoot.

ALL High powered rifles (anything over 556 or 7.62x39AK) MUST be fired on the rifle lanes ONLY.

Full automatic firearms are ONLY allowed with the PRIOR PERMISSION and at the discretion of CGDr and proper paperwork must be presented in advance. (Pistol and Small Rifle (556/AK) calibers only will be allowed.)

All air guns and BB guns are allowed .

For firearms not mentioned here, check with CGD prior to use on the range.

PERMISSABLE AMMUNITION:

Standard commercial and reloaded ammunition is permitted. Any type ammunition designed for penetrating metal is not permitted ON STEEL TARGETS. Shotguns may ONLY shoot Steel Shot, No exceptions. No tracer, incendiary, armor piercing, gas or explosive ammunition permitted.

BRASS RETRIEVAL: Brass caught in a BRASS CATCHER before hitting the ground can be kept. All brass that touches the ground MUST be left on the ground UNTIL CEASE FIRE! NO EXCEPTIONS!!!!

Protocol for putting up, scoring, taking down targets: Ranges may be hot (active 15 minutes

hot and 5 minutes cold while bell rings.)

AFTER CEASE FIRE BELL STARTS RINGING shooters shall say:

1. "Cease firing" or "Stop"
2. "Unload"
3. "Show clear"
4. "Is the line clear on the right? On the left?" Everyone shows his/her neighbor on either side that the action is clear. When shown clear all shooters will respond:
5. "The line is clear"
6. "Move out of position" Everyone steps back behind the yellow line - ALL FIREARMS

ARE ON THE TABLE, unloaded, open and clear. DO NOT TOUCH FIREARMS DURING A CEASE FIRE

7. "Range Clear. Go forward, score targets, and paste". Go out to the range, score, paste put up/take down targets, and then return to the firing area. When EVERYONE (including 100yrd Rifle shooters) is back to the firing area:

AND THE BELL HAS STOPPED RINGING

9. "Back to the line"
10. "Is the line ready?"

INITIAL _____

If you are ready, then say "Ready", if not, then say "Not ready".

12. If there is anyone not ready, the line will wait until that person (or persons) states "Ready".

13. When everyone is ready, then: "Commence fire

When 100yrd rifle shooters or Skeet Shooters are going down range, they should place the "man downrange barricade" on the firing line so as to be seen by all shooters at the line . Ensure you remove the barricade upon your return.

Primary Gun Safety Rules:

1. ALWAYS keep the gun pointed in a safe direction (down range).
2. ALWAYS keep your finger off the trigger until ready to shoot.
3. ALWAYS keep the gun unloaded until ready to use at the firing line.
4. Know your target and what is behind it.
- 5 Be sure the gun is safe to operate.
6. Know how to use the gun safely. (Load, handle, fire, unload and make the gun safe.)
7. Use only the correct ammunition for the gun
8. Never use alcohol or drugs before or while shooting
9. Wear eye and ear protection at all times on the range
10. Follow the instructions of the Range Safety Officers (RSO).

No cleaning of firearms is allowed on the range. No chemicals, including solvents and lubricants are to be used on the bench or in the range area. You must provide your own tools for minor adjustments (sight, etc) and those **adjustments MUST be made in the firing lane with the gun unloaded, open, clear and pointed down range.** Crazy Gun Dealer cannot provide tools for you to work on your firearm. All firearms must have sights installed and the sights must be used for all shots.

Absolutely no sales of firearms or ammunition are permitted on range property. Appropriate dress is required at all times Any equipment or other personal items in/on a shooting lane left unattended are at the owner's risk. Crazy Gun Dealer is not responsible for lost or stolen items. Store extra gear against wall behind yellow firing line, out of everyone's way. Shoot only at your own target.

Hunting and shooting at any wildlife is strictly prohibited everywhere on the Crazy Gun Dealer Range.

Members are responsible to clean up after themselves and guests. Deposit trash in the appropriate trash cans or pack it up and take it home. Keep your range clean!

The Range Area Entrance Gate is to be kept locked by members at all times. Make certain that the padlock has been snapped into place and locked behind you on entry and exit. Do not share your key with anyone. Your key is numbered and assigned to you. If anyone is caught with your key who is not on your membership, you will be subject to immediate loss of membership with NO refunds. Lost keys should be reported immediately and replacement key cost is \$50. **INITIAL_____**

Keep all vehicles on the established roads and parking areas. Parking on grass can be slippery and you can easily get stuck when wet. Crazy Gun Dealer will NOT pull out anyone who gets stuck and will not be responsible for wrecker expense.

I authorize Crazy Gun Dealer to utilize photos and/ or videos of me, my family and children for promotional use on Crazy Gun Dealers web sites and/or marketing materials. This waiver is perpetual.

SHOOTING SHOTGUNS & SKEET

Skeet MUST be bought from CGD ONLY and MUST be shot with STEEL shot ONLY. NO lead shotgun shells or reloaded shotgun shells may be brought into the range area. RSO MAY inspect ALL shotgun shells you bring into the range area. Any lead or reloaded shotgun shells or ANY shells that are NOT clearly marked STEEL SHOT will be confiscated and NOT Returned or reimbursed. If ANY lead shotgun shells are taken from you, you MUST buy ALL your Steel Shot from the pro shop for shotgun shooting. If you are caught shooting lead shotguns shells at the Crazy Gun Range, knowingly or unknowingly, you agree to pay \$2500.00 per occurrence and agree that you will owe this amount without dispute and will pay within 5 business days of demand. Should you refuse to pay in full, you agree to pay all attorney’s costs, court costs and collection costs plus interest at the highest legal amount allowed in the state of Texas until all paid in full.

Skeet shooting is a 2 person operation. Either bring a second person, or pair up with another shooter. SINGLE Shooters CANNOT Shoot Skeet- No Exceptions!

Shooting 100 Yard Rifle Lanes

All Rifles must be shot from the **BENCH REST ONLY** and thru the appropriate target culvert and at the appropriate target down range. During Cease Fire, shooters will place a “Down Range” barricade blocking the rifle lanes to prevent anyone from shooting and additionally one visible to the RSO from his watch post so it is OBVIOUS when someone is down range and the firing line is NOT safe.

These RULES may be amended or modified at ANY time by Crazy Gun Dealer By Posting Amendments or Modifications in the Pro Shop For All To See. You accept and Agree to ANY amendments or modifications by PASSING by the posting in the Pro Shop while Registering to shoot. Your Continued shooting after posting is your implied consent and acceptance to the amended, modified or new rules and regulations.

Crazy Gun Dealer Reserves the right to impose time limits during periods of high demand. When there is a wait and a member is timed out of their lane, they may immediately go onto the wait list for another lane.

Once you have read and initialed the last rule, Tell a Crazy Gun Dealer staff member **“Wounded Warriors are my Heroes”**.
